

VOTE TO RECALL CA GOVERNOR GAVIN NEWSOM IN 2021

CALIFORNIA WILL BE VOTING ON THE RECALL OF GOV. GAVIN NEWSOM ON SEPTEMBER 14, 2021. HERE ARE A FEW OF THE HUGE REASONS TO RECALL NEWSOM:

1. NEWSOM CORRUPTION

- a. Newsom is corrupt and favors his large donors and his family over CA citizens.
- b. FOR EXAMPLE, Newsom and his wife Jennifer (through a nonprofit) accepted over \$700,000 from PG&E, its foundation and PG&E employees over the 2 decades when Newsom has been seeking public office. (See Washington Post and campaign disclosure documents)

2. NEWSOM'S LOCKDOWNS HURT TENS OF MILLIONS OF CA CITIZENS

- a. Newsom used a power-hungry grab to institute one of the most restrictive state lockdowns in 2020 and 2021.
- b. It resulted in the permanent closure of tens of thousands of CA businesses.
- c. It was arbitrary and unfair to small businesses in CA. Note: Newsom's winery businesses were not subjected to the same rules.
- d. Newsom violated his own rules with an unmasked restaurant birthday party when the rest of CA was in lockdown.
- e. Unemployment rates in CA hit 9% in December 2020 during Newsom's lockdown and made CA one of the top 5 states for unemployment.
- f. CA was one of the most restrictive states mandating strict public-school closures when most states re-opened schools safely long ago.
- g. Newsom's children attended private in-person school while public schools were closed by Newsom.
- h. This Newsom lockdown hurt tens of millions of CA citizens and Newsom's lockdown usually bore no relationship to science.

3. NEWSOM'S INCOMPETENT LEADERSHIP

- a. The Unemployment Development Dept. had \$11-31B of Covid unemployment fraud under Newsom.
- b. Newsom oversaw forest mismanagement for years, cutting CalFire's budget by \$150 million, in the face of great loss in deadly fires.
- c. Newsom was CA governor and Lt governor during the years when CA has been experiencing increasing and untreated CA homelessness.
- d. Newsom's leadership provides sanctuary state protection of criminals.

4. NEWSOM OVERSEES THE OVER-TAXATION OF CA CITIZENS

- a. CA is 8th in the nation for highest sales and local taxes - averaging 8.68%.
- b. CA is 49th in the USA for business tax climate - almost last (NJ is 50th)
- c. CA has the highest personal income marginal tax rate in the USA at 13.3%. This may rise to 16% soon if Newsom has his way.
- d. CA gas excise tax is highest in the nation (64 cents/gal and mandated to climb).

5. NEWSOM'S TAXATION AND REGULATION CAUSES CA CITIZENS TO LEAVE

- a. California is losing jobs, people, and talent.
- b. CA is in the top 10 in 2020 for outward migration to states with a better business climate.
- c. Over 18,000 businesses have left CA between 2008-2019 when Newsom has held high offices in CA.
- d. Some large CA businesses are relocating out-of-state: Tesla, HP, Oracle, Charles Schwab, & McKesson, to name a few.
